ACADEMIC SESSION START NOTICE – April 04, 2024

Dear Parent / Guardian,

We have stepped into the new **Academic Session 2024 – 25** and as an educational institution; we would like to extend a heartfelt thanks to our parents/guardians for their continued support and co-operation to the **Ramanujan Group of Educational Institutions (R.G.E.I.)**. Through this communication, we would like to share the following information:

1. **Student Portal / Mobile App:** The primary mode of communication with the student/parent/guardian shall be the Student Portal and Mobile App ONLY. The school expects the parents/guardians to visit the Mobile App **on a daily basis** for any updates regarding the Academic Calendar, Activity Calendar, Homework, Assignments, Examination Date Sheets, Student Attendance, Fee Payment, Notices, Photo Gallery, etc.

Kindly download the “SRPS Prayagraj” mobile app from the Google Play Store or Apple Store and use the login credentials, as shared via sms on the registered mobile number, to access the Mobile Portal. Please contact the school’s Admin Office in case of any clarifications.

2. **Joining Docket:** The School Management strongly believes in planning the academic session at the very beginning while ensuring that the same is adhered to in sacrosanct. In view of the same, the joining docket containing the School Diary, Academic Calendar, Split Syllabus & Activity Charter shall be shared with the students within ten (10) working days from the start of the new academic session.
3. **Discipline & Punctuality:** Since the inception in 2005; our school has been known for discipline and punctuality and continuing with the legacy, we urge the parents/guardians to ensure that their wards reach the school well in-time. Strict adherence to school timings is required. Students are expected to arrive at least 10 minutes before the start of school. Gates will be closed promptly at 7:25 a.m. After three (03) late marks, the child will be sent home and latecomers will not be permitted entry after this time. No reasons will be accepted.

The Principal reserves the right to admission in the school campus even if there is a delay of **1 minute from the school clock** displayed at the main gate.

4. **Attendance:** As communicated from time-to-time, the students shall not be allowed to appear for the Annual Examination if he/she has not met the **minimum attendance criteria of 75%**. We urge to the parents to ensure that their respective wards adhere to the attendance guidelines as set by the CISCE, New Delhi.

2. **Fee Payment Guidelines:** Below are the details of Fee Payment guidelines, not limited to, for your kind reference:

- The School Fee once paid will not be refunded under any circumstances.
- The School Fee will be charged quarterly for **12 months** payable in 4 (four) installments upto **15th of each quarter - April, July, October & January.**
- Fees are to be deposited by Cash/Cheque/Draft in HDFC Bank Limited, S.P. Marg, Civil Lines, Prayagraj during the bank working hours on all business days.
- The Bank will accept payment of fees by local Cheques/Drafts drawn in favour of **“Srinivasa Ramanujan Public School”**, Prayagraj.

Cheque Payment Details:

- Cheques will be collected by the bank upto **13th of the due month only.** The cheque that gets cleared after 15th of the due date will be liable for the fine amount. The fine amount will be visible on the Parent Portal and/or Mobile App.
- Please make sure the cheque is complete in all aspects before depositing the same at the bank, viz.: (a) The name and address of the branch (b) The date (c) Your Bank Account Number (d) Your Signature (e) All cuttings / alterations must be authenticated with your full signature.

- c. Please ensure that there are adequate funds in your account to cover the Cheque issued by you. Cheques not honoured for any reason could lead to serious repercussions apart from a monetary penalty of **Rs. 300/-** (Three Hundred Only).
- d. Once a cheque is dishonored, the amount of the dishonoured cheque, along with a penalty of Rs. 300/- (Three Hundred Only) in cash plus the other late fee charges already given in the fee booklet has to be deposited at the school office.

Late Payment Details:

- a. Depositing the fee by the due date is the sole responsibility of the parent. Under no circumstance should the dues be allowed to fall in arrears. If the fee falls in arrears, the student's name will be struck off the roll without further notice and re-admission may not be granted. If re-admission is granted, a fee of **Rs. 2000/-** (Two Thousand Only) will be charged as re-admission fee along with the fine applicable for the subsequent months.
- b. Details of Fee Payment and Late Payment charges are mentioned herewith. Please be informed that the late payment charges are automatically calculated by the Student Portal and HDFC Bank application. Under no circumstance does the school hold the authority to make changes to the late payment charges or waive the same. So kindly pay the dues on a timely basis in order to avoid the addition of late payment charges.
- c. Fee (in cash) must be deposited by 15th of the due month. If the 15th of the due month falls on a Sunday/holiday, **fees will only be collected along with the Fine amount** on the next working day of the bank. No extension will be allowed.
- d. In case any previous installment of fees remains unpaid and the fees of the current installment is paid, it will result in the imposition of a penalty of **Rs. 2000/- (Two Thousand Only)** for the previous unpaid installment along with the fine applicable for the subsequent months.
- e. Names of Students whose fees are not paid for **2 months** would be struck off the rolls.
- f. Students, whose dues are not settled before the commencement of the Terminal/Annual Examination, will not be allowed to appear in the examination.

Mid-Session Student Withdrawal:

If a student is withdrawn mid-session; monthly dues will have to be paid upto September/March, as the case may be. Parents/Guardians, whose wards are withdrawn in the mid-session, will have to pay the following dues.

- (i) **April to June** who apply for T.C after 31st March of the session but before 30th April.
(ii) **October to March** (i.e. entire session) who apply for T.C. after 30th September of the session.

 - c. Duplicate issue of Diary: Rs. 200 (Two Hundred Only)
 - d. Duplicate issue of I-card: Rs. 100 (One Hundred Only)
 3. Certificates will only be issued on request by the Parent/Guardian and the school will require a bare minimum of 02 (two) working days' time for processing the same.
 4. Parents are requested to please keep the payment receipts for their record and for reference, if any, when required by the school.
 5. Parents/Guardians may deposit the fee of the whole year at the beginning of session if they wish to do so. However, no concessions will be applicable on the total amount.
